- 1. Village Staff Reports. The new police car has had the decals put on and is here for the Board to look at. Public Works Director Derick Fisher is doing some meter pits and culverts. He must take the dump truck in for some repairs. He has upgraded some communications equipment at the WTP. They will be able to see things in real time. Need VFD's and PLC's. The salt shed is finished. There is room enough to separate the piles of salt. Derick would like to upgrade to a better salt that is less corrosive. Derick would like to discuss how the firehouse is charged (not charged) for water that is used. Most water is used for parties that are booked, car washes, showers, etc. Mayor Luedke said that if the water were just used for filling trucks, it would be different. Mayor Luedke and Derick will check to see what other Villages do. Derick called Macon County about a property on Route 48 that is a code violation. Trustee Berry asked what was going on with the property on N North Street. Huffman Lawn Care is not able to do it. Looking Good Lawn Care will give us a bid. Derick is spraying tracks on Thursday. We need to get the electric done at the Farm Shed. We have ARPA money still to use for that.
- 2. Mayor's Report. Mayor Luedke said that Oct 16th the CEO class will be here for a semester. There were soil borings done last week for the new water plant. Our IL Funds have made \$14.843.00 in interest in 8 months.
